**扩大营收来源**  
**高峰海内外竞标更多工程**

(吉隆坡 28 日讯) 高峰控股 (Bpuri, 5932, 主板建筑股) 将会积极在海内外竞标更多工程, 来扩大营业额来源。

高峰控股执行主席拿督莫哈末费沙表示: “我们将会继续在海内外竞标更多的工程, 以扩大营业额来源。”

高峰控股发布文告指出, 该公司在 2007 年已在海外, 获得总值 9 亿 4300 万令吉的工程。此外, 该公司也刚于今年 2 月获政府颁发一项吉隆坡-瓜拉雪兰莪大道为期 40 年的收费站特许经营权。

该文告指出, 上述大道的建筑工程预期将会从今年第三季开始动工。

莫哈末费沙也表示: “尽管建筑领域在 2007 年因原料成本高涨而面对很多挑战, 但是我们已经采取应对方案来加强公司的业绩表现。因此, 我们相信, 高峰控股将会继续表现不俗。”

此外, 该公司董事局也建议为截至 2007 年 12 月 31 日止的财政年, 派发 4% 的终期股息 (每股扣除 26% 所得税), 使 2007 年每股总派息率为 6%。

在截至 2007 年 12 月 31 日止, 高峰控股营业额已从 2006 年的 4 亿 9160 万令吉, 增长 24% 至 6 亿零 790 万令吉。同时, 该公司税前盈利也从去年的 640 万令吉, 剧增 33% 至 850 万令吉。

### Bina Puri Major Contribution ~ Bidding for more projects locally and overseas

Bina Puri Holdings will aggressively bid for more contracts locally and overseas to expand the sources of revenue.

Bina Puri Holdings, Executive Chairman Dato' Mohamed Feisal Ibrahim said “we will continue to bid for more projects locally and overseas expand our sources of revenue”

In Bina Puri announcement, the company has in year 2007 secured RM 943 million of projects in overseas. Besides, the company has just secured a toll concession from Government of Malaysia for the KL-Kuala Selangor expressway with concession period of 40 years.

In the statement, the above expressway is expected to commence by 3<sup>rd</sup> quarter 2008

Dato' Mohamed Feisal said "even though the company encounters a lot of challenges in 2007 due to material cost increased, but we have responded to these factors with initiatives taken to enhance performance. Hence we believe Bina Puri Holdings will continue to deliver good result.

Also, The Board has recommended a final dividend of 4% per share less 26% income tax for financial year 31 December 2007 making the total dividend declared for the current year to 6% per share

As at 31 December 2007, Bina Puri recorded a 24% increase in the revenue of RM 607.9 million as compared to RM 491.6 million recorded in 2006.

At the same time the profit before tax increased by 33% to RM 8.5 million as compared to RM 6.4 million recorded in the previous year
